# **Penny Bain**

Penny Bain B.A., L.L.B., L.L.M., is a retired member of the BC Law Society and former Executive Director of the BC Centre for Elder Advocacy and Support (BCCEAS). During her career she worked for seven years as the Executive Director of the BC Institute Against Family Violence and fourteen years as a senior manager with the BC legal aid plan. In her retirement she serves on the boards of directors of BCCEAS and Women Against Violence Against Women.

## **Anne Beveridge**

Anne Beveridge B.Sc., LL.B., LL.M., is a semi-retired lawyer who teaches part-time online for Thompson Rivers University Open Learning Business Faculty. She has a continuing interest in access to justice issues having spent several years as a poverty lawyer at the North Shore Community Law Office and later as a client services manager at the BC Legal Services Society (legal aid). Until recently she provided pro bono legal services at the Silver Harbour Seniors' Centre in North Vancouver—a role that has given her first hand insight into difficulties faced by aging women.

#### Elsie Dean

Elsie Dean has been active since retirement working for the rights of elders and in particular women elders. As President of the Board of Directors of 411 Seniors Centre Society

(1977) she is helping the Society develop new programs and services that will meet the needs of elders now and in the future.

#### **Donna Dickison**

Donna Dickison worked in a long-term facility for 29 years. She was very involved with her trade union, the Hospital Employees Union, for many years, serving as local shop steward and chairperson, as well as in her local community. She is a member of the Aboriginal Women's Action Network. Donna has been retired for the last five years.

## Jill Hightower

Jill Hightower continues to be a strong advocate for older women. She retired as Executive Director of the BC Institute Against Family Violence in 1998. She then became a founding partner in a small research and education consulting group focused on public policy, health and social issues affecting older women. Jill has published and presented papers in print, at conferences in North America and Europe, and at community forums across Canada. Jill is a Co-Chair and a member of the board of directors of the BC Association of Community Response Networks.

## **Linda Light**

Linda light has worked in the area of violence against women, children, and older people for over 30 years, 22 of those in the provincial government and the last eight as a consultant. She has helped develop cross-sector policies, training initiatives, and a wide range of educational resources; conducted research, and written extensively in this field.

#### **Bella Maude**

Bella Maud is a 70 years old Metis woman from Winnipeg. Before retirement, she held clerical positions in a number of hospitals, and in 1989 started to work for the Hospital Employees Union. She remains a union activist. Upon early retirement in 2000 she was cochair of the South Vancouver Health Committee. She currently volunteers for Aunt Leah's, which helps mothers with housing, living skills, and other needs and supports youth coming out of foster care. She has three children of her own.

#### **Gertrude Pierre**

Gertrude Pierre is a Sechelt Nation Elder and a residential school survivor. Attending residential school for 10 years did not hold Gertrude back. After years of healing she graduated with a Bachelor of Social Work in 2011 at the age of 65. She currently works with the Aboriginal Front Door Society and the Vancouver Aboriginal Community Policing Centre to help people in the Downtown East Side.

#### **Andrea Rolls**

Andrea Rolls worked nearly 30 years in provincial government providing community supervision of offenders and family court mediation and conciliation, as well as senior policy planning and advice to government on victim services, restorative justice and crime prevention programs. Her particular interest in elder law reform resulted from involvement with the BC Adult Abuse and Neglect Prevention Collaborative and activities that demonstrated how law reform and accessibility to justice could improve the safety and well-being of older adults. Andrea is a member of the BC Law Institute's board of directors and is enthusiastic that BCLI's work includes community input to inform and identify new areas for law reform.

### **Carol Ross**

Carol Ross is Executive Director of Parent Support Services Society of BC (PSS). She has extensive experience in community based advocacy and resource development, especially in areas relating to Family and Poverty Law. PSS provides a unique focus on researching and developing supportive resources and programs on and for Grandparents Raising Grandchildren and other kinship care providers.

## The Honourable Madam Justice Lynn Smith

Lynn Smith, B.A., LL.B., LL.D. (Hon.) was appointed to the Supreme Court of British Columbia in 1998. She served as a Justice of that Court until her retirement from the bench in 2012. In 2005-06, she was Executive Director of the National Judicial Institute, on secondment from the Court. She is a Judicial Associate of the National Judicial Institute and serves on the faculty of the Charter and Evidence Workshops as well as the New Federally-Appointed Judges Program. She has been involved in international judicial education exchanges with China, Scotland, Ghana and Viet Nam.

Prior to her appointment as a judge, she practised law, specializing in civil litigation. She taught law at the University of British Columbia 1981-97 in areas including Constitutional Law, Evidence, Civil Litigation, and Real Property. She has published books and articles in the fields of Charter equality rights, civil litigation and evidence, human rights, and women's equality. She was Dean of the U.B.C. Law Faculty 1991-97.
